Discussion of the Draft Master Plan

Ledebur started off the discussion with reading an excerpt of a letter the City received from Fritz Wagner, PH.D., Emeritus Professor, stating that he thought that the Draft Master Plan was a quality report (see attached for full letter).

Paul Montagno stated that he has made changes to some Draft Master Plan chapters and to the Matrix.

In the Introduction, it is noted that the Master Plan is not a Legislative Document. Definitions have been added for the words "should", "will" and "shall" for clarification purposes.

Based on public comment, the title of Chapter 8 has been changed from Sustainability to Environmental Quality.

In the Matrix, the tasks have been separated into Planning Commission Tasks and City Council Initiatives. The Timeline has also been removed from City Council Matrix.

Staff requested that the light-colored text be changed to a darker color for easier reading and for reproduction purposes.

Based on public comment, the Planning Commission suggested revising the 1st paragraph on page 16 to be more neutral and should be changed to "north of the tracks". The title should also be re-worded to Main Street Frontage.

Planning Commission reached a consensus that they liked the changes that Paul Montagno made to the Draft Master Plan and Matrix.

Montagno and Ledebur concluded by discussing the next steps involved in adopting the plan by the Planning Commission and City Council.

Meeting adjourned at 8:40 p.m.
