Item #03-11 MASARACCHIA

A variance was requested by Joe and Cindy MASARACCHIA of 717 S. Main - Tax ID#06-12-475-027 for a variance from sections 5.04 B1 and B2, and Section 10.06 to allow for construction of a fence in the front yard 3 feet from the sidewalk with an 8 foot high arbor on a non-conforming lot.

Ann Valle the next door neighbor appeared and was in favor of the request as she stated it beautified the neighborhood.

The board discussed that they have granted other setback variances for fences closer than three feet from the sidewalk and felt that granting this variance was in line with others in the Village.

Motion by Dewey Ketner, seconded by Richard Bauer to grant the variance as requested 3 Ayes, 0 No, 2 Absent. Motion carried.
